## DECD POLICY ON BUS TRAVEL ENTITLEMENT

Students are entitled to transport assistance if they reside five or more kilometres from their nearest public school, and use a bus for more than $50 \%$ of the week.

## The following categories apply to students who require school bus travel:-

## 1. Students with a right to travel

- These students are eligible for school bus travel if they reside more than five kilometres from their nearest public school, and are attending their school of right (determined by the nearest departmentally provided school bus service).

2. Students who require school bus travel to access a choice of school

- These students are not eligible to receive school bus travel to attend their school of choice, however there are some provisions in the DECD School Transport Policy for this to occur.
- Whilst parents may exercise their right to a choice of school when enrolling their children, enrolment acceptance does not give automatic right of travel on a school bus servicing that school of choice.
- For students who seek school bus travel to bypass their nearest public school (which is also determined by the nearest departmentally provided school bus service) to attend a choice of school, the following criteria will be applied on receiving application:-
- Applicants must state valid reasons for seeking bus approval;
- Approval must be given by specific parties including the Principal of the school of right.
- Permission to travel as an ineligible student must be applied for annually.

Both Principals must approve all applications for government school students travelling beyond their nearest public school.
3. Students who reside within five kilometres of their nearest public school

- These students are not eligible for school bus travel.
- Permission may, however, be given for these students to travel on a bus subject to approval from the Principal managing the bus, and seating being available on the bus
- In these circumstances students should not be transported away from their nearest public school.

4. Students approved by the Education Director to bypass their nearest public school as eligible travellers.

- These students can be approved by the Education Director as eligible travellers to bypass their nearest public school subject to certain criteria being met.
In reference to categories 2 and 3, parents will be required to sign an agreement, which specifies conditions of approval to travel.


## Please note:

- Students using the bus less than $50 \%$ of the time become ineligible, and may be required to discontinue usage should an eligible passenger require a seat
- $\quad$ Students granted conditional approval will need to make an annual request by $30^{\text {th }}$ November
- If buses become full, eligible students take first priority and conditionally approved students will not be able to travel on the bus until space become available again
- Approval may be withdrawn if poor behaviour persists.
